WSOX-FM'S "AACA MUSEUM AUTOS & ALES TICKET GIVEAWAY OCTOBER 21 - 25, 2024" CONTEST OFFICIAL RULES

The Station will conduct the WSOX-FM's "AACA Museum Autos & Ales Ticket Giveaway October 21 – 25, 2024" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. - 2. Contest Period. The Contest period will begin at 5:00 AM ET on October 21, 2024 and will run weekdays from 5:00 AM ET to 10:00 AM ET through 10:00 AM ET on October 25, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- How to Enter and Win. Listen to the Station during the Contest Period. When the Station gives a cue 3. to call, listeners must call the Station at 888-909-1096. Caller #10 to the Station, as determined by the Station in its sole discretion, will be eligible to participate in the contest. The Station will give the contestant three brand slogans and ask the contestant to identify whether each slogan is a beer brand or an automobile brand. If the contestant answers at least two slogans correctly, they will be eligible to win the prize after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. If the contestant answers incorrectly, the contest will be repeated with the next caller until a winner is found. All entries may be played on the air. *Time* Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-theair signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.
